DOCTOR'S DECLARATION (Scotland)

The Health Protection Network's guidance document Rabies: Guidance on Prophylaxis and Management in Humans in Scotland (Health Protection Scotland website <u>https://www.publichealthscotland.scot</u> (latest version 04 Sept 2023) states that the rabies vaccine should be given to those who frequently handle bats in the UK. If the handling of bats is as part of an individual's paid work, their employer is deemed responsible for the payment for the vaccine. Where an employer cannot be identified or if the individual's involvement with bats is in a voluntary capacity (e.g. a bat carer) the pre-exposure rabies vaccine should be available, free of charge from the NHS. Individuals should approach their GP practice for vaccination.

Following an initial course and one-year booster the guidance recommends that bat workers in Scotland should have their antibody level tested every three years and given a booster if necessary, these titre tests and boosters should be free of charge.
