## **DOCTOR'S DECLARATION (Wales)**

UK Health Security Agency (UKHSA) and the Department of Health have agreed that preexposure rabies vaccines should be available, free of charge, to those who regularly handle bats in the UK in a voluntary capacity. It has been agreed that UKHSA will provide the vaccine for Wales as well as England.
